# Part A: Pupil premium strategy plan

## Statement of intent

We have high aspirations for all our pupils and are determined to provide an education that enables all to achieve academically and socially. As a staff, it is our shared belief, that social disadvantage should not be a barrier to learning and through the use of pupil premium funding we are working to reduce these barriers, accelerate progress and narrow the attainment gap.

We will consider the challenges faced by vulnerable pupils, such as those who have a family worker, social worker and young carers. The activity we have outlined in this statement is also intended to support their needs, regardless of whether they are disadvantaged or not.

Our aim is that all pupils, regardless of background reach their full potential, attaining well and achieving good outcomes. We want them to value their education and drive their desire to learn and do well regardless of their background. This includes challenging our high attainers and supporting those who have additional needs to do their very best. We also strive to engage families in education and support them in having high aspirations for their children.

The activity we have outlined in this statement is also intended to support their needs, regardless of whether they are disadvantaged or not. We want all our pupils to strive to meet our CORE Values of:

- Safety
- Togetherness
- Respect
- Integrity
- Excellence

Our approach will be responsive to common challenges and individual needs, rooted in robust diagnostic assessment, not assumptions about the impact of disadvantage. The approaches we have adopted complement each other to help pupils excel. To ensure they are effective we will:

- ensure disadvantaged pupils are challenged in the work that they're set
- act early to intervene at the point need is identified
- adopt a whole school approach in which all staff take responsibility for disadvantaged pupils' outcomes and raise expectations of what they can achieve

## Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge																																													
1	Assessments, observations, and discussions with pupils indicate under-developed oral language skills and vocabulary gaps among many disadvantaged pupils. These are evident from Reception through to KS2 and in general, are more prevalent among our disadvantaged pupils than their peers.																																													
2	Assessments, observations, and discussions with pupils suggest disadvantaged pupils generally have greater difficulties with phonics than their peers. This negatively impacts their development as readers.																																													
3	<p>Our assessments and observations indicate that the education and well-being of many of our disadvantaged pupils have been impacted by partial school closures to a greater extent than for other pupils. 4	<p>Our assessments (including wellbeing survey), observations and discussions with pupils and families have identified social and emotional issues for many pupils largely due to a lack of enrichment opportunities during school closure. These challenges particularly affect disadvantaged pupils, including their attainment.</p> <p>9 pupils (5 of who are disadvantaged) have a family worker.</p> <p>30 pupils (19 children and 63% PP currently require additional support with social and emotional needs. All of our disadvantaged pupils in need of additional support have accessed, or are scheduled to access, our emotional wellbeing provision in school (ELSA, reading therapy).</p> <p>Key adults are assigned to each pupil premium child and are timetabled to read and check in with the children at least once a week.</p>

6	<p>Attendance is the most common factor linked with safeguarding concerns.</p> <p>54% of concerns logged relating to pupil attendance were linked to Pupil Premium Children. This is statistically significant when considering Pupil Premium pupils make up just 18% of the school population.</p> <p>74% of all concerns raised in the 2022-23 academic year were linked to Pupil Premium children.</p>
